Executive Summary

On 3/22/2017 12:00:00 AM - 4/11/2017 11:59:00 PM our campus conducted the Campus Climate Survey. After approval from NCC's IRB committee, the Survey was administered to students, faculty and staff.

By SUNY policy this uniform survey ascertains faculty and staff awareness of policies and resources, and student experience with and knowledge of reporting and college adjudicatory processes for sexual harassment, including sexual violence and other related crimes.

Results indicated that faculty and staff are generally aware of the policies and laws, and resources. There is an indication that more information, outreach and follow-up is needed to provide awareness and up to date information to faculty and staff.

Students indicated they were not generally aware of the policies and laws, and resources. There is an indication that more information, outreach and follow-up is needed to provide up awareness and up to date information to the students.

Of the <u>830</u> total faculty, staff and students who responded 33.94% knew of the Title IX Coordinators role on campus.

The Title IX Coordinator of Nassau Community College, has reviewed all results and will hold a meeting with the Sexual Harassment Committee to review specific results and to further detail recommendations based on the findings.

The data was collected online with use of Campus Labs as a 3rd party platform. The sample size was generated by the campus. The population selected were all full-time faculty, staff, administrators and part-time staff with job title as Security Officers. The survey was also sent to full-time and part-time students enrolled in spring 2017 excluding students - under age 18; in continuing education program; high school enrichment; senior observers; visiting.

Results

The Title IX Coordinator's role

The roles of a Title IX Coordinator in regards to sex discrimination/sexual assaults/sexual misconduct is understood by approximately 22% of the faculty/staff respondents. Most students recorded that incidents that had occurred were perpetrated by acquaintances or former dating partners.

Approximately 97.78% of the faculty/staff respondents knows the campus has policies and procedures specifically addressing sexual assault.

Campus policies and procedures addressing sexual assault; Faculty/staff Responses

- 12-Faculty/staff understands the difference between college disciplinary process and criminal justice system.
- 13-Faculty/staff knows someone who is incapacitated cannot provide consent.
- 14-Faculty/staff are familiar with the policy for alcohol and/or drug use amnesty in reporting sexual violence cases.
- 15-Faculty/staff 10.90% of those respondents know the Title IX Coordinator is whom a victim/survivor or witness can formally disclose a sexual assault on campus.
- 16- Approximately 22% of the faculty/staff respondents knows the roles of a Title IX Coordinator in regards to sex discrimination/sexual assaults/sexual misconduct.
- 17- Approximately 56.29% of the faculty/staff respondents know how to find the Title IX Coordinator.
- 18- Approximately 8.24% of the faculty/staff respondents is aware that the Title IX Coordinator Has the availability of Sexual and Interpersonal Violence Resources.
- 19- Approximately 88.62% of the faculty/staff respondents reported during the last year, NO student had disclosed to them that they were a victim of an unwanted sexual experience (including sexual assault), domestic violence, dating violence, or stalking, regardless of where such incident is reported to have occurred.
- 20- Approximately 28.57% of the faculty/staff respondents reported for the most recent disclosed incident, they did report the disclosure to the Title IX Coordinator, Campus Police/Public Safety, Student Affairs, or another office on campus.
 - -Interesting enough 50.00% Preferred not to respond.

Campus policies and procedures addressing sexual assault; Student Responses

- **1-6** Approximately 64.44% of the student respondents knows the campus has policies and procedures specifically addressing sexual assault.
- 13-Approximately 7.49% of the student respondents know the Title IX Coordinator Is whom a victim/survivor or witness can formally disclose a sexual assault on campus.
- 14- Approximately 50.73% of the student respondents do not know what are the roles of a Title IX Coordinator in regards to sex discrimination/sexual assault/sexual misconduct.
- 15- Approximately 74.64% of the student respondents do not know how to find the Title IX Coordinator.
- 16- Approximately 6.06% of the student respondents is aware that the Title IX Coordinator has the availability of Sexual and Interpersonal Violence Resources.
- 17- Approximately 74.23% of the student respondents reported during the last year, they have NOT experienced unwanted sexual comments, sexual slurs, or demeaning jokes.
- 18- Approximately 94.48% of the student respondents reported during the last year, that they are NOT aware of someone viewing them sexual activity or nakedness without their consent, or taking pictures or recordings without their consent.

- 19- Approximately 83.54% of the student respondents reported during the last year, they have NOT received unwanted sexually suggestive digital communications, either words or images or both, including emails, texts, social media communications, or in letters or other written communications.
- 20- Approximately 86.77% of the student respondents reported during the last year, NO ONE fondled, kissed, or rubbed up against the private areas of their body without consent for that activity or attempted.
- 21- Approximately 92.52% of the student respondents during the last year, NO ONE has fondled, kissed, or rubbed up against the private areas of their body without consent for that activity. Completed.
- 22- Approximately 93.81% of the student respondents reported during the last year, NO ONE has removed any of their clothes even without consent for that activity or has attempted.
- 23- Approximately 93.75% of the student respondents reported during the last year, NO ONE has removed some of their clothes without consent for that activity. Completed.
- 24- Approximately 93.21% of the student respondents reported during the last year, NO ONE has performed oral sex on them or forced them to perform oral sex without consent for that activity. Attempted.

29/30- Approximately 63.89% of the student respondents for the most recent incident, the person was NOT affiliated with the campus community.

How and where to report sexual violence as a victim/survivor or witness? Faculty/staff Responses

-Approximately 20% of the faculty/staff respondents knows:

The definition of sexual assault

How to report a sexual assault

Where to go to get help if you or someone you know is sexually assaulted

To whom one can speak confidentially about a sexual assault

Policies prohibiting sexual assault

- -Approximately 63.13% of the faculty/staff respondents reported being aware of the distinction between confidentiality and privacy before this survey.
- -Approximately 44.44% of the faculty/staff respondents strongly agrees: If a student were sexually assaulted, they know how to advise them on where to get help on campus.
- --Approximately 38.89% of the faculty/staff respondents agrees: If a student were sexually assaulted, they know how to advise them on where to get help on campus.

How and where to report sexual violence as a victim/survivor or witness? Students Responses

-Approximately 16.66% of the student respondents knows where to report:

Sexual assault

Sexual harassment

Domestic violence

Dating violence

Stalking

I do not know how to report any of the above.

Discussion and next steps

The survey results reflect a general challenge in communicating sexual violence resource information to the campus community. Also, a concise instructional guide needs to be distributed to students, faculty and staff in response to the role of the Title IX coordinator and notifying the Title IX coordinator in regards to sex discrimination/sexual assaults/sexual misconduct.

Furthermore, more time is needed to dedicate a more comprehensive data analysis for NCC.

NCC will continue to educate all new and current students, as well as faculty and staff; using a variety of best practices aimed at educating the entire college community in a way that decreases violence and maintaining a culture where sexual assault and acts of violence are not tolerated.

- Programming surrounding large recurring campus events;
- Partnering with neighboring SUNY and non-SUNY colleges to offer training and education;
- Partnering with State and local community organizations that provide outreach, support, crisis intervention, counseling and other resources to victims/survivors of crimes to offer training and education. Partnerships can also be used to educate community organizations about the resources and remedies available on campus for students and employees seeking services; and
- Outreach and partnering with local business those attract students to advertise and educate about these policies.

Specific to the SUNY Sexual Violence Prevention (SVP) Campus Climate Survey, Campus Labs is providing the technology to administer the survey and analyze the collected data. Campus Labs has also provided consultation in the form of two consultants whose role is to advise SUNY representatives on the logistics and administration of the survey.

Data Security:

Campus Labs is committed to maintaining the highest standards in data security. To protect information used in internet transactions (e.g. online surveys, data reports), Campus Labs uses the following security techniques and procedures:

- Secure login access (username and password) is required to access all data reports
- Information is exchanged via Secure Socket Layer (SSL) that uses 128-bit encryption
- Information requests must pass through multiple hardware and software security firewalls
- Campus Labs' data center is monitored 24/7 and access is restricted to authorized parties with validated key cards
- Data is backed up every hour internally
- Data is backed up every night to a centralized backup system, with offsite backups in the event of catastrophe.
- Campus representatives will have access to all data for their campus only.
- SUNY Administrators will have access to the data of all participating campuses
- Respondent identifiers are hidden from the SUNY and campus representatives administering the SVP Campus Climate Survey. At no time will SUNY or campus representatives be able to see respondent identifiers linked to individual's responses.
