

## OSHA 500 SERIES TRAINING COURSES AT NCC

**\*IMPORTANT NOTE\* – NO EXCEPTIONS.** Anyone who intends to register at NCC for OSHA 500 Construction **must** comply with the following policy:



1. You **must complete** the OSHA 510 standards prerequisite course and **submit a copy of proof of certification.**
2. **If you are taking the 500 Trainer course for the first time, you must submit the completed, signed and dated first 4pp. of a Prerequisite Verification Form in advance** to [trainerverification@sph.rutgers.edu](mailto:trainerverification@sph.rutgers.edu) in order to determine whether you have the requisite five years of safety experience to qualify as a trainer.
3. Your registration is **not complete until payment is received, proof of OSHA 510 completion is submitted and work experience is approved by Rutgers School of Public Health.**
4. You **must pass both a written exam and an oral presentation** at the end of the Trainer course in order to receive trainer authorization.

### OSHA 500 TRAINER COURSE IN OCCUPATIONAL SAFETY & HEALTH STANDARDS FOR CONSTRUCTION INDUSTRY PREREQUISITE

This course is designed for personnel in the private and public sector interested in teaching the 10- and 30-hour construction safety and health outreach program to their employees and other interested groups. Special emphasis is placed upon those topics that are required in the 10- and 30-hour programs, as well as on those that are most hazardous, using OSHA standards as a guide. Course participants are briefed on effective instructional approaches and the effective use of visual aids and handouts. This course allows the student to become a trainer in the Outreach Program and to conduct both a 10- and 30-hour construction safety and health course and to issue cards to participants verifying course completion. **Bring lunch.**

### OSHA 502 UPDATE FOR CONSTRUCTION INDUSTRY OUTREACH TRAINERS

**Prerequisite:** See "Trainer Update Requirements" below

This course is designed for private and public sector personnel who have completed the OSHA 500 Trainer course and who are active trainers in the Outreach Program. It provides an update on OSHA construction standards, policies, and regulations and renews trainer authorization for another four years. **Bring lunch.**

### OSHA 502 for Construction Industry: Trainer Update Requirements

Authorized Construction Outreach trainers are required to attend the OSHA 502 Construction Trainer Update once every four years to maintain their trainer status. Prior to registration, students must provide a copy of their current Outreach Training Program trainer card to show proof of completion of the Construction Trainer Course. Outreach trainers must complete the OSHA 502 Construction Trainer before their expiration date. OSHA eliminated the 90-days grace period past expiration as of December 2018. If the authorization expires, the trainer must retake the OSHA 500 Trainer course (28 Contact Hours) and the OSHA 510 Construction Standards (26 Contact Hours), if completed more than **seven years previously.**

### OSHA 510 OCCUPATIONAL SAFETY AND HEALTH STANDARDS FOR CONSTRUCTION INDUSTRY:

**See\*IMPORTANT NOTE\***No Prerequisites. This course covers OSHA policies, procedures, and standards, as well as construction safety and health principles. Topics include scope and application of the OSHA construction standards. Special emphasis is placed on those areas that are the most hazardous, using OSHA standards as a guide. You must pass a closed book exam to receive a Certificate of Completion. **Bring lunch.**
